4. First aid measures

After inhalation: fresh air

Suitable extinguishing media: CO₂, powder, foam, spray water.

Special risks: Combustible. Development of hazardous combustion gases or vapours possible in the event of fire.
The following may develop in event of fire: sulfur oxides, nitrogen oxides.

Special protective equipment for fire fighting:

Do not stay in dangerous zone without self-contained breathing apparatus.

Other information: Prevent fire-fighting water from entering surface water or groundwater.

6. Accidental release measures

Person-related precautionary measures:

Avoid generation of dusts; do not inhale dusts.

Environmental-protection measures:

Do not allow to enter sewerage system.

Procedures for cleaning / absorption:

Take up dry. Forward for disposal. Clean up affected area.

7. Handling and storage

Handling: No further requirements.

Storage: Tightly closed. Dry. At -20 °C.

Personal protective equipment:

Respiratory protection: required when dusts are generated.

Eye protection: required

Hand protection: Use recommended
